

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Coldfields Community 2008 Budget Amendment #1)

RESOLUTION NO. 08-253

1 **WHEREAS, at a regular scheduled meeting of the Baboquivari District Council held on April 12,**
2 **2008; and**

3 **WHEREAS, the Coldfields Community Representatives presented a budget amendment #1 for**
4 **their 2008 budget to carryover monies from FY 2007 in the amount of \$205,563.44; and**

5 **WHEREAS, on March 12, 2008, Coldfields Community, with seven members present, approved to**
6 **carryover the FY 2007 amount of \$205,563.44 adding to their original FY 2008 budget**
7 **of \$119,298.18 for a revised budget amount of \$324,861.62; and**

8 **WHEREAS, the budget amendment #1 will apply as follows:**

20 **WHEREAS, this budget amendment #1 will increase the Coldfields Community FY 2008 original**
21 **budget of \$119,298.18 by \$205,563.44, for a revised FY 2008 budget amount of**
22 **\$324,861.62, and increases the overall Baboquivari District Budget of \$1,632,492.32 to**
23 **\$1,838,055.76.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
25 **Coldfields Community 2008 budget amendment #1 to carryover FY 2007 monies in the**
26 **amount of \$205,563.44 into their original 2008 budget of \$119,298.18, for a revised**
27 **budget amount of \$324,861.62, and increasing the overall Baboquivari District Budget**
28 **of \$1,632,492.32 to \$1,838,055.76.**

29 **BE IT FINALLY RESOLVED that any changes in the justifications, additions and/or the transfer of**
30 **funds between budget line items are to be reviewed by the Budget and Finance**
31 **Committee and approved by the Tohono O'odham Legislative Council.**


