

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Tohono O'odham Nation Delegation to the National Congress of American
Indians's 2008 Mid-Year Session)

RESOLUTION NO. 08-256

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to consult with the**
2 **federal government and other Indian tribes on all matters within the Council's**
3 **authority(Constitution of the Tohono O'odham Nation, Article VI, Section 1(f)); and**

4 **WHEREAS, the National Congress of American Indians ("NCAI") will hold its 2008 Mid-Year Session**
5 **in Reno, Nevada from June 1-4, 2008; and**

6 **WHEREAS, the Tohono O'odham Nation has worked closely with the NCAI and with Indian tribes**
7 **across the United States to address numerous national issues of importance to Indian**
8 **people; and**

9 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to continue its national-level**
10 **involvement in these issues by participating in the NCAI 2008 Mid-Year Session.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
12 **authorizes the following representatives to attend and serve as the Tohono O'odham**
13 **Nation's delegation to the NCAI 2008 Mid-Year Session:**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby delegates authority**
23 **to Chairman Ned Norris, Jr. to act as the Tohono O'odham Nation's voting delegate,**
24 **and Representative Timothy Joaquin to act as the Nation's alternate voting delegate**
25 **to the NCAI 2008 Mid-Year Session.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH. Day**
27 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
28 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
29 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
30 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
31 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
