

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2009 Projected Revenues to the Nation in the Amount of \$74,902,000)**

RESOLUTION NO. 08-259

1 **WHEREAS, the Budget and Finance Committee and the Executive Office reviewed the revenue**
2 **projections and available revenue for FY 2009; and**

3 **WHEREAS, the Budget and Finance Committee and the Executive Office recommend the adoption**
4 **of the FY 2009 revenue projections in the amount of \$74,902,000 to fund the Nation's**
5 **tribal budgets for FY 2009.**

6 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
7 **approves the attached projected revenues in the amount of \$74,902,000 for the**
8 **purpose of funding the FY 2009 tribal budgets of the Tohono O'odham Nation.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20th. Day**
10 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,338 FOR; -0- AGAINST; -0-**
11 **NOT VOTING; and 196.5[04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
12 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
13 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
14 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


