

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Carry Over of Unexpended FY 08 Funding for the Tohono O'odham Nation**  
**Fire Department for the Construction of a Permanent Facility)**

RESOLUTION NO. 08-264

1  
2 WHEREAS, the Tohono O'odham Nation Department of Public Safety Fire Department has  
3 deemed it critical and necessary to increase Fire Protection Services to the Tohono  
4 O'odham Nation, particularly the new Desert Diamond Casino/Hotel; and

5 WHEREAS, the Tohono O'odham Legislative Council approved a request of \$2,800,000 for the  
6 construction of a permanent fire/police substation; and

7 WHEREAS, the actual construction of the proposal fire/police station will not begin until FY 09;  
8 and

9 WHEREAS, the Fire Department requires \$2,625,870.00 to fund the cost of construction during  
10 FY 09.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves  
12 carryover of unexpended FY 08 funds in the amount of \$2,625,870 into FY 09 to  
13 construct a fire/police substation in accordance with the budget attached hereto.

14 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the  
15 Chairman and any designated official to expend and administer the budget as  
16 attached, provided that any amendment affecting the funds or funding level shall  
17 be submitted for further prior approval by the Tohono O'odham Legislative Council.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> Day  
20 of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;  
21 -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)  
22 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
23 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
24 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
