

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting and Approving the Executive Branch Fiscal Year 2009 Tribal Budget and  
Appropriating Funds in the Amount of \$57,554,424.38)**

RESOLUTION NO. 08-265

1 **WHEREAS, the Executive Branch has prepared and presented its fiscal year 2009 tribal budgets**  
2 **to the Tohono O'odham Legislative Council; and**

3 **WHEREAS, the Executive Branch Fiscal Year 2009 Budget for the period from October 01, 2008**  
4 **through September 30, 2009 has been presented to the Legislative Council both in**  
5 **summary as Schedule 1 as well as in detailed budgets (collectively, "Executive Branch**  
6 **FY 2009 Budget") that by this reference are all incorporated into this Resolution.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby appropriate**  
8 **\$57,554,424.38 from general fund revenues to fund the Executive Branch Fiscal Year**  
9 **2009 Budget.**

10 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby (1) adopts**  
11 **and approves the Executive Branch FY 2009 Budget in the amount of \$57,554,424.38**  
12 **and (2) authorizes the expenditure of funds appropriated to and in accordance with**  
13 **the Executive Branch FY 2009 Budget.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
15 **Chairman, Vice-Chairman and any designated official are authorized to administer**  
16 **the Executive Branch FY 2009 Budget, provided however that any amendments**  
17 **affecting the aggregate total of the funds originally budgeted for the purposes for**  
18 **which the funds were budgeted shall be submitted for prior approval by the Tohono**  
19 **O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup>. Day**  
22 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,353.4 FOR; -0- AGAINST;**  
23 **181.1 NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Section 1**  
24 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**
