

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY2009 State IV-B Contract Budget for the Division of Child Welfare; and**  
**Approving the 10% Indirect Cost Rate for Title IV-B Budgets)**

**RESOLUTION NO. 08-276**

1 **WHEREAS, the Tohono O'odham Nation, through the Division of Child Welfare Services, has**  
2 **historically operated a Family Preservation Program to promote safe and stable**  
3 **families; and**

4 **WHEREAS, the Tohono O'odham Nation has executed a State IV-B Contract, Intergovernmental**  
5 **Agreement between the Department of Economic Security and the Tohono O'odham**  
6 **Nation for the term of April 1, 2005 through September 30, 2008, as approved by**  
7 **Resolution No. 05-331; and**

8 **WHEREAS, the Tohono O'odham Nation, Family Preservation Program, under this State IV-B**  
9 **Contract, invoices and receives additional funds from the State for services that the**  
10 **Family Preservation Program provides to Tohono O'odham families, thereby**  
11 **increasing funding which is critically needed for the provision of services; and**

12 **WHEREAS, the Tohono O'odham Nation, Family Preservation Program wishes to continue**  
13 **providing services, invoice for these services, and receive funds in FY2009 from the**  
14 **State through the State IV-B Contract for services to Tohono O'odham families; and**

15 **WHEREAS, the Executive Branch developed and obtained Committee approval of the FY2009 State**  
16 **IV-B Contract Budget in the amount of \$72,710.30, attached and incorporated by this**  
17 **reference, to be effective October 1, 2008 through September 30, 2009 and requests**  
18 **authorization to expend these funds in FY 2009; and**

19 **WHEREAS, the U.S. Department of Health and Human Services, Administration for Children and**  
20 **Families (ACF), has notified the Department that The Child and Family Services**  
21 **Improvement Act of 2006 (Public Law 109-288) restricts administrative costs to 10%**  
22 **starting October 1, 2007 for Title IV-B budgets. The Department requests approval to**  
23 **submit this budget with the following restricted 10% amount for indirect costs as:**

- 24 **1. \$6,610.03 Indirect Costs for FY 2009 State Title IV-B Contract Budget, Acct. 12-**  
25 **1313.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
27 **approve and authorize the Executive Branch to expend funds for the FY2009 State IV-B**  
28 **Contract Budget attached, effective October 1, 2008 through September 30, 2009, in the**  
29 **amount of \$72,710.30, inclusive of budget modifications throughout this period.**

1 **BE IT FURTHER RESOLVED that the Executive Branch is authorized to restrict the Indirect Costs**  
2 **to 10% in Title IV-B budgets as required by The Child and Family Services**  
3 **Improvement Act of 2006 (Public Law 109-288) in the following amount:**

- 4 1. **\$6,610.03 Indirect Costs for FY 2009 State Title IV-B Contract Budget, Acct. 12-**

6 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman and any**  
7 **designated official are hereby authorized to negotiate, execute and expend the**  
8 **contract, provided however, that any budget amendments affecting the funds or**  
9 **funding levels shall be submitted for further prior approval by the Tohono O'odham**  
10 **Legislative Council.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup>. Day**  
12 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
13 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
14 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
15 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
16 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




