

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the FY 2009 Tohono O'odham Department of Health & Human Services,**  
**Division of Community Health – Women Infants & Children (WIC) Program**  
**Proposed Budget of \$166,980.00 Account # 12-1436)**

**RESOLUTION NO. 08-278**

1 **WHEREAS, the Tohono O'odham Nation has successfully operated the Tohono O'odham**  
2 **Department of Health and Human Services-Division of Community Health-Women**  
3 **Infants Children (WIC) Program which provides preventive health care; and**

4 **WHEREAS, the Inter-Tribal Council of Arizona through an Intergovernmental Agreement receives**  
5 **funds from the United States Department of Agriculture for programs designed to**  
6 **benefit women, infants and children; and**

7 **WHEREAS, the Tohono O'odham Nation has entered into a Memorandum of Agreement with the**  
8 **Inter-Tribal Council of Arizona to fund and operate the Women Infants and Children**  
9 **(WIC) Program which commenced on October 01, 2002 through September 30, 2006,**  
10 **which was approved through Resolution Number 02-439; and**

11 **WHEREAS, the services provided to eligible clients have been beneficial and services continue to**  
12 **be necessary to help alleviate nutritional health risks and improve the health of**  
13 **individuals at risk; and**

14 **WHEREAS, WIC has submitted the FY09 WIC Budget and proposal in the amount of \$166,980.00.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
16 **approve and authorize expenditures of the FY09 attached budget in the amount of**  
17 **\$166,980.00 from the Inter-Tribal Council of Arizona to continue to operate and**  
18 **provide services to eligible women, infants and children.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
20 **Nation's Official, to wit: the Chairman and Vice Chairman and any designated official**  
21 **are authorized to negotiate and execute the Memorandum of Agreement associated**  
22 **with this program, provided however, that any amendments affecting the funding or**  
23 **funding level of the Memorandum of Agreement shall be submitted for further**  
24 **approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> Day**  
26 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
27 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1**  
28 **(d)(2)&(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**






