Food Distribution Program Budget - Account No. 11-1315)

RESOLUTION NO. 08-285

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2008 grant with the**
3 **United States Department of Agriculture (USDA); and**

4 **WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'odham**
5 **Nation and the people; and**

6 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to apply for FY2009 United**
7 **States Department of Agriculture funds to assist eligible individuals and families with**
8 **commodity foods; and**


9 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**
10 **Division, Food Distribution Program has submitted for review and approval, the**
11 **proposal and budget in the amount of \$192,444.28.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
13 **authorizes the FY09 Food Distribution Program budget in the amount of \$192,444.28,**
14 **in accordance with the attached budget.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
16 **Chairman and any designated official to expend and administer the budget as**
17 **attached, provided that any amendments affecting the funds or funding level shall**
18 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH. Day**
20 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
22 **& (3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
