**(Approving Department of Health and Human Services, Division of Family Assistance – FY09**  
**Low Income Home Energy Assistance Program – Budget and Proposal, Account No. 12-1310)**

**RESOLUTION NO. 08-288**

1 **WHEREAS, the Low income Home Energy Assistance Program (LIHEAP) has been beneficial in**  
2 **providing financial assistance to eligible low-income households in meeting utility**  
3 **needs, i.e., electricity, propane, water and wood; and**

4 **WHEREAS, the final allocation to the Tohono O'odham Nation for FY2009 through the State of**  
5 **Arizona, Department of Economic Security, Community Services Administration is**  
6 **\$53,980.00; and**

7 **WHEREAS, the Tohono O'odham Nation is hereby submitting the Service Methodology and budget**  
8 **for FY2009 funding through the State of Arizona, Department of Economic Security,**  
9 **Community Services Administration in the amount of \$53,980.00 for contract period**  
10 **July 01, 2008 through June 30, 2009; and**

11 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**  
12 **Division, Low Income Home Energy Assistance Program has submitted the FY09 Low**  
13 **Income Home Energy Assistance Service Methodology and budget in the amount of**  
14 **\$53,980.00 for review and approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
16 **authorizes the expenditure of the FY200 Low Income Home Energy Assistance**  
17 **Program (LIHEAP) budget in the amount of \$53,980.00 in accordance with the**  
18 **attached budget.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairman and Vice-Chairman any designated official to expend and administer the**  
21 **budget as attached, provided that any amendments affecting the funds or funding**  
22 **level shall be submitted for further prior approval by the Tohono O'odham**  
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
25 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
26 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
27 **& (3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**




