

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Consolidated Healthy O'odham Promotion Program FY 2009 Budget
(October 1, 2008 – September 30, 2009))**

RESOLUTION NO. 08-289

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians grant**
2 **through FY 2009 with a base budget of \$1,929,827.02; and**

3 **WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council approved the**
4 **establishment of the Community Based Diabetes Prevention Program, funded by the**
5 **Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of**
6 **1997; and**

7 **WHEREAS, by Resolution Number 2000-182, the Tohono O'odham Legislative Council approved**
8 **the name change of the Community Based Diabetes Prevention Program to the**
9 **Healthy O'odham Promotion Program; and**

10 **WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the**
11 **Fiscal Year 2009 base budget of \$1,929,827.02.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 13 **1. Approves and authorizes expenditures for the Division of Health Promotion**
14 **Program Fiscal Year 2009 base budget of \$1,929,827.02.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
16 **Chairman, Vice-Chairman, and any designated official to expend and administer the**
17 **budget as attached, provided that any amendments affecting the funds or funding**
18 **level shall be submitted for further final approval by the Tohono O'odham Legislative**
19 **Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH. Day**
21 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
23 **& (3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
