

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2009 -Title III B, C-1, C-2, E, D-Health Promotion, and Nutrition Services**  
**Incentive Program (NSIP) Budgets - July 1, 2008 through June 30, 2009)**

**RESOLUTION NO. 08-293**

1 **WHEREAS, the Tohono O'odham Nation has successfully operated the Senior Services program**  
2 **for the Elders of the Nation; and**

3 **WHEREAS, funding for the operation of the Senior Services Program is possible in part by Title**  
4 **III of the Older Americans Act funds administered through the Inter-Tribal Council**  
5 **of Arizona (ITCA); and**

6 **WHEREAS, the services provided to the Elders and Caregivers are beneficial and services**  
7 **continue to be necessary in order to provide nutrition, transportation, socialization**  
8 **and health promotion support to the Elders; and Caregiver support to the Caregivers**  
9 **of Elders and Elders caring for Grandchildren; and**

10 **WHEREAS, the Administration on Aging fiscal Year 2009 Title III-B \$24,315.00, C-1 \$88,673.00, C-2**  
11 **\$60,510.00, E \$26,557.00, D- Health Promotion \$12,520.00 and the Nutrition Services**  
12 **Incentive Program (NSIP) \$10,511.00 program budgets were prepared to utilize the**  
13 **Title III of the Older Americans grant to continue nutrition, socialization,**  
14 **transportation and Caregiver support services to eligible Elders and Caregivers of the**  
15 **Nation; and**

16 **WHEREAS, the FY 2009 budgets were prepared in accordance with the Executive Branch FY-2009**  
17 **Budget Development Instructions which authorizes 2.5 percent Cost of Living salary**  
18 **increases to be effective October 1, 2009.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
20 **approves:**

- 21 **1. The Administration on Aging, fiscal year 2009 Title III B \$24,315.00; C-1**  
22 **\$88,673.00; C-2 \$60,510.00; E \$26,557.00; D-Health Promotion \$12,520.00 and**  
23 **Nutrition Services Incentive Program (NSIP) \$10,511.00 budgets that will be**  
24 **necessary to maintain current services.**

25 **BE IT FINALLY RESOLVED that Tohono O'odham Nation officials to wit, the Chairman, Vice-**  
26 **Chairman, and any designated official is hereby authorized to negotiate and execute**  
27 **the grant, provided however, that any amendments affecting the funding or funding**  
28 **levels of this contract shall be submitted for further prior approval by this Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
30 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
31 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
32 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
33 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
34 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
35 **Stat. 984).**


