

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2009 Department of Health and Human Services Head Start Budgets)**

RESOLUTION NO. 08-298

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Head**  
4 **Start Program to provide educational, health, mental health and parent involvement**  
5 **services to children, three to five years of age; and**

6 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**  
7 **budgets as attached and incorporated by this reference, to be effective November 1,**  
8 **2008 through October 31, 2009 and request authorization to expend funds:**

- 9 1. **Head Start Program Budget-\$1,475,216.00 + \$148,854.00(IDC)=1,624,070.00.**
- 10 2. **Head Start T & TA Budget-18,330.00.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
12 **the above listed Head Start Program Budget and the Head Start T & TA Budget for the**  
13 **Period November 1, 2008 through October 31, 2009.**

14 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
15 **Executive Branch to expend funds for the Program listed above and as attached in the**  
16 **amount indicated, effective November 1, 2008 through October 31, 2009.**

- 17 1. **Head Start Program Budget-\$1,475,216.00 + \$148,854.00(IDC) =1,624,070.00.**
- 18 2. **Head Start T & TA Budget-18,330.00.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
20 **Nation's Official, to wit the Chairman, Vice-Chairman and any designated official are**  
21 **authorized to negotiate and expend the grant, provided however, that any**  
22 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
23 **further prior approval.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH .**  
25 **Day of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1 (d)(2) (3)&(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
28 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**


