

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2009 Department of Health and Human Services Child Care and  
Development Fund Budgets)**

RESOLUTION NO. 08-299

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating Child**  
4 **Care Services to provide child care services to its young tribal members; and**

5 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**  
6 **Budgets as attached and incorporated by this reference, to be effective October 1,**  
7 **2008 through September 30, 2009 and requests authorization to expend funds for the**  
8 **FY 2009 Child Care and Development Fund (CCDF) in the amount of \$903,759.00 in**  
9 **the following budgets:**

- 10 1. **FY 2009 CCDF Mandatory Funds - \$502,014.52 + \$71,679.48 (IDC) = \$573,694.00.**
- 11 2. **FY 2009 CCDF Discretionary Funds - \$276,552.16 + \$53,512.84 (IDC) =**  
12 **\$330,065.00.**

13 **NOW, THEREFOR, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
14 **the above listed CCDF Mandatory Funds Budget, and CCDF Discretionary Funds**  
15 **Budget for period October 1, 2008 through September 30, 2009.**

16 **BE IT FURTHER RESOLVED that the Executive Branch is hereby authorized to expend funds for the**  
17 **program listed herein above and as attached in the amounts indicated, effective**  
18 **October 1, 2008 through September 30, 2009 for the FY 2009 Child Care and**  
19 **Development Fund Budgets:**

- 20 1. **FY 2009 CCDF Mandatory Funds - \$502,014.52 + \$71,679.48 (IDC) = \$573,694.00.**
- 21 2. **FY 2009 CCDF Discretionary Funds - \$276,552.16 + \$53,512.84 (IDC) =**  
22 **\$330,065.00.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Nation's Official, to wit: the Chairman and any designated official are authorized to**  
25 **negotiate and expend the budget, provided however, that any amendments affecting**  
26 **the funds or funding levels of the budget shall be submitted for further prior**  
27 **approval.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH .**  
29 **Day of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
30 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
31 **Section 1 (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
32 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat. 984).**


