

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to Expend FY 2009 Revenue, in the Amount of \$473,365.80, for the
Solid Waste Management Program FY 2009 Revenue Budget 83-0003 and to approve the
deposit of the \$473,365.80 into the Bank of America Solid Waste Revenue Account)

RESOLUTION NO. 08-302

1 **WHEREAS, the Tohono O'odham Legislative Council approved a dedicated account for the Solid**
2 **Waste Management Program Revenue budget 83-0003 through Resolution 98-236;**
3 **and**

4 **WHEREAS, the Solid Waste Management Program will submit a FY2009 Revenue budget, in the**
5 **amount of \$473,365.80; and**

6 **WHEREAS, the \$473,365.80 will be deposited to the Bank of America Solid Waste Revenue**
7 **account; and**

8 **WHEREAS, the Solid Waste Management Program FY2009 Revenue budget 83-0003 has been**
9 **reviewed by the Legislative Natural Resources Committee and the Budget and**
10 **Finance Committee.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 12 **1. Authorizes the expenditure of FY2009 revenue, in the amount of \$473,365.80,**
13 **for the Solid Waste Management Program FY2009 Revenue budget 83-0003, in**
14 **accordance with the budget attached hereto.**
- 15 **2. Approves the deposit of the \$473,365.80 into the Bank of America Solid Waste**
16 **Revenue account.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairman and any designated official to expend and administer the budget as**
19 **attached, provided that any amendments affecting the funds or funding level shall**
20 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
22 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
24 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
27 **Stat. 984).**


