

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to Expend FY2008 Indian Health Services (IHS) Memorandum of
Agreement Carryover Funds for Water Resources Department FY2009 IHS
Budget 11-5016)

RESOLUTION NO. 08-305

1 WHEREAS, the Tohono O'odham Legislative Council approved a Memorandum of Agreement
2 between the Water Resources Study Program and the Indian Health Service (IHS) and
3 budget 11-5016 through Resolution 01-313; and

4 WHEREAS, the Water Resources Study Program has now become the Water Resources
5 Department; and

6 WHEREAS, the Water Resources Department has accumulated carry forward funds in FY2008
7 in the amount of \$20,000.00; and

8 WHEREAS, the Water Resources Study Program FY2009 IHS budget 11-5016 has been reviewed
9 by the Legislative Water Resources Committee and the Legislative Budget and
10 Finance Committee.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the
12 expenditure of FY2008 carry forward funds in the amount of \$20,000.00 for the Water
13 Resources Department FY2009 IHS budget 11-5016, in accordance with the budget
14 attached hereto.

15 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
16 Chairperson and any designated official to expend and administer the budget, as
17 attached, provided that any amendments affecting the funds or funding levels of the
18 budget shall be submitted for further prior approval by the Tohono O'odham
19 Legislative Council.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH.
21 Day of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-
22 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by
23 Section 1 (d)(2) (3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
24 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
25 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
26 18, 1934 (48 Stat. 984).




