3	WHEREAS,	the Water Resources Department has proposed a re-occurring annual Southern
4		Arizona Water Rights Settlement Act (SAWRSA) budget for FY2009 and beyond, using
5		the interest from the SAWRSA Trust Fund; and
6	WHEREAS,	the Water Resources Department has proposed a SAWRSA budget for FY2009, in the
7		amount of \$864,541.57, using funding from the SAWRSA Trust Fund; and
8	WHEREAS,	the line items 740 COMPUTER COST, 772 RM BUILDING, and 774 COMPUTER
9		MAINTENANCE will be added to the FY2009 SAWARSA budget 21-1525; and
10	WHEREAS,	an in kind match of \$8,422.00 from the FY2009 SAWRSA budget 21-1525 will be used
11		for the Water Resources Department FY2009 EPA 106 budget 11-5017; and
12	WHEREAS,	the FY2009 SAWRSA budget 21-1525 has been reviewed by the Legislative Water
13		Resources Committee and the Legislative Budget and Finance Committee.
14	NOW, THERI	EFORE BE, IT RESOLVED that the Tohono O'odham Legislative Council hereby:
15		1. Appropriates \$864,541.57 from the SAWRSA Trust Fund to the Water
16		Resources Department FY2009 SAWRSA budget 21-1525.
17		2. Approves a re-occurring annual SAWRSA budget for the Water Resources
18		Department from the SAWRSA Trust Fund.
19		3. Approves the addition of the line items 740 COMPUTER COST, 772 RM
20		BUILDING, and 774 COMPUTER MAINTENANCE to the Water Resources
21		Department SAWARSA budget 21-1525.
22		4. Approves an in kind match of \$8,422.00 from the FY2009 SAWRSA budget 21-
23		1525 for the Water Resources Department FY2009 EPA 106 budget 11-5017.
24		5. Approves the expenditure of \$864,541.57 for the Water Resources
25		Department FY2009 SAWRSA budget 21-1525, in accordance with the budget
26		attached hereto.

28		Chairman and any designated official to expend and administer the budget as
