

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of No-cost Grant Extensions for Brownfields 128(a) Tribal Response
Program Account # 11-5122 for FY2009)**

RESOLUTION NO. 08-309

1 **WHEREAS, the TONEPO requested a no-cost extension to US EPA Region 9 for the Brownfields**
2 **128(a) Tribal Response Program (RP 96988301) for FY2009; and**

3 **WHEREAS, the extension will allow TONEPO staff to continue the current work plan tasks**
4 **through FY2009; and**

5 **WHEREAS, there is \$117,098.04 (Account # 11-5122) in savings to continue the program; and**

6 **WHEREAS, the program period has been changed from October 01, 2007 through September 30,**
7 **2009; and**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
9 **a no-cost extension carryover for the Brownfields 128(a) Tribal Response Program**
10 **(RP 96988301) in the amount of \$117,098.04, which extends the project period to**
11 **September 30, 2009.**

12 **BE IT FURTHER RESOLVED that the TONEPO is authorized to expend all available funds awarded**
13 **pursuant to Cooperative Agreement (RP 96988301).**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
15 **Nation's Official, to wit: the Chairman, Vice-Chairman and any designated official**
16 **are authorized to negotiate and execute the grant, provided however, that any**
17 **amendments affecting the funding or funding levels of the grant shall be submitted**
18 **for further prior approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH,**
20 **Day of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
