

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY-09 Budget for Youth Transportation Art Grant Carryover Funds)**

RESOLUTION NO. 08-316

1 **WHEREAS, the Planning Department's former Transportation Program applied for and**  
2 **received funding for Youth Transportation Art grant in the amount of \$50,000.00 in**  
3 **FY-05; and**

4 **WHEREAS, for FY-06 the carry forward budget was \$49,424.17 and amended to \$224,424.17 by**  
5 **receiving the entire allocation of \$175,000 per agreement and for FY-07 the budget**  
6 **remained at \$224,424.17; and**

7 **WHEREAS, for FY-08 the carry forward budget of \$180,332.96 with pending agreements the**  
8 **remaining balance of \$154,693.21 will be carried forward for FY-09; and**

9 **WHEREAS, this project is funded by a Pima Association of Governments grant to enhance**  
10 **community pride by involving District youth in designing public transportation art;**  
11 **and**

12 **WHEREAS, the Planning Department's Administration is requesting approval of the FY-09**  
13 **Budget of remaining carryover funds in the amount of \$154,693.21; and**

14 **WHEREAS, the grant will be administered by the Planning Department's Administration.**

15 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby authorizes**  
16 **and approves the budget amount of \$154,693.21 and approves the attached budget**  
17 **in the amount of \$154,693.21.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
19 **Chairperson and any designated official to expend and administer the budget as**  
20 **attached, provided that any amendments affecting the funds or funding level shall**  
21 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH .**  
23 **Day of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
25 **Section 1 (d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
26 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
28 **18, 1934 (48 Stat. 984).**




