

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Economic Development Budget)

RESOLUTION NO. 08-318

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these**
4 **funds shall be pursuant to appropriations or budgets" authorized by resolution or**
5 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2));**
6 **and**

7 **WHEREAS, the Legislative Council appointed a delegation ("Nation's Delegation") to explore**
8 **economic development projects; and**

9 **WHEREAS, after extensive consultations, studies, and analysis, the Legislative Council approved**
10 **a draft arrangement to promote economic development; and**

11 **WHEREAS, the Legislative Council has been briefed on additional actions that are necessary to**
12 **promote economic development and has developed an Economic Development**
13 **Budget, which is incorporated by this reference, for that purpose.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
15 **hereby appropriates \$892,667.00 from the General Fund for the Economic**
16 **Development Budget, which is hereby approved, provided:**

- 17 (1) **That such funds shall remain available for expenditure from the effective date**
18 **of this resolution through September 30, 2009.**
- 19 (2) **The Nation's Chairman is authorized to administer the Economic Development**
20 **Budget in consultation with the other members of the Nation's Delegation.**
- 21 (3) **Any amendments affecting the funding or funding levels of the Economic**
22 **Development Budget shall be submitted for prior approval by the Legislative**
23 **Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH. Day**
25 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1**
27 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**


