11	WHEREAS,	the Legislative Council has been briefed on additional actions that are necessary to			
12		promote economic development and has developed an Economic Development			
13		Budget, which is incorporated by this reference, for that purpose.			
14	NOW, THEI	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council			
15		hereby appropriates \$892,667.00 from the General Fund for the Economic			
16		Development Budget, which is hereby approved, provided:			
17		(1) That such funds shall remain available for expenditure from the effective date			
18		of this resolution through September 30, 2009.			
19		$(2) \qquad \textbf{The Nation's Chairman is authorized to administer the Economic Development}$			
20		Budget in consultation with the other members of the Nation's Delegation.			
21		(3) Any amendments affecting the funding or funding levels of the Economic			
22		Development Budget shall be submitted for prior approval by the Legislative			
23		Council.
