the Tohono O'odham Nation has received notification of funds increase to the 638 1 WHEREAS. 2 BIA Master Contract in the amount of \$170,813 for Transportation; and 3 WHEREAS. the Planning Administration is requesting the acceptance of the funds to complete the Nation's Long Range Transportation and the Road Inventory Projects; and 4 5 WHEREAS, the Planning Department Administration is requesting approval of the attached budget of \$175,542.95 which includes indirect costs to be authorized for FY-2008. 6 7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby 8 approve and authorize the 2% Transportation budget in the amount of \$175,542.95 9 effective upon approval thru September 30, 2008. 10 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham 11 Nation's Official, to wit: the Chairman, Vice-Chairman and any designated official 12 are authorized to negotiate and execute the budget, provided however, that any 13 amendments affecting the funds or funding levels of the budget shall be submitted 14 for further prior approval by the Tohono O'odham Legislative Council. 15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH . 16 Day of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-17 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by 18 Section 1 (d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by 19 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant 20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 21 18, 1934 (48 Stat. 984). 22 TOHONO O'ODHAM LEGISLATIVE COUNCIL 23 24 25 26 Verlon M.
