

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Health and Human Services, Division of Child Welfare**  
**Assistance, FY 2008 PHASE One Program Budget Modification/Amendment #1 -**  
**Account No. 01-1443)**

RESOLUTION NO. 08-345

1 WHEREAS, the Child Welfare Division, Phase One tribal Budget Account No. 01-1443 was  
2 approved by the Tohono O'odham Legislative Council by Resolution No. 07-588; and

3 WHEREAS, Child Welfare Phase One budget amendment #1 is contributing \$5,500.00 for the cost  
4 of the replacement vehicle for the Food Distribution Program, which will be applied  
5 to the total cost of \$25,000.00. The remaining balance will be cost shared among the  
6 Health Transportation, Community Health, DHHS Executive budgets; and

7 WHEREAS, the Tohono O'odham Department of Health and Human Services, Child Welfare  
8 Division, has submitted for review and approval, budget modification/amendment  
9 #1 in the amount of \$5,500.00.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and  
11 authorizes the FY08 Child Welfare Division - Phase one budget modification/  
12 amendment #1 in the amount of \$5,500.00.

13 BE IT FURTHER RESOLVED that the Child Welfare Division is hereby submitting budget  
14 modification/amendment#1 to decrease line items and to revise the budget narrative  
15 revision to include cost share for purchase a vehicle in the amount of \$5,500.00, for  
16 the Food Distribution Program.

17 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby approves and  
18 authorizes any designated official to expend and administer the budget as attached,  
19 provided that any amendments affecting the funds or funding level shall be  
20 submitted for further prior approval by the Tohono O'odham Legislative Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day  
22 of JUNE, 2008 at a meeting at which a quorum was present with a vote of 2,207.0 FOR; 227.9  
23 AGAINST; 99.60 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
24 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by  
25 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
27 18, 1934 (48 Stat. 984).


