3	WHEREAS,	on May 07, 2007, a Food Distribution vehicle was destroyed by fire; and
4	WHEREAS,	the Food Distribution Program requires a replacement vehicle to deliver commodity
5		foods to communities on and off the Nation; and
6	WHEREAS,	an insurance payment in the amount of \$3,265.00 was received and \$21,735.00 is
7		requested to purchase a replacement vehicle for a total of \$25,000.00; and
8	WHEREAS,	Community Health, O'odham in Mexico (OIM) budget is cost-sharing the total
9		replacement amount with a contribution of \$5,500.00. The insurance payment of
10		\$3,265.00 will be applied to the $$25,000.00$ , and the remaining will be cost-shared
11		$between \ the \ Executive \ Director, Health \ Transportation \ and \ Child \ Welfare \ budgets;$

13	WHEREAS,	the  Community  Health, O'odham  in  Mexico  (OIM)  is  submitting  budget  Amendment
14		#1 to add the capital equipment line item to contribute the cost-shared amount for
15		the vehicle replacement; and
16	WHEREAS,	$the \ Community \ Health, O'odham\ in\ Mexico (OIM)\ budget is also\ modified\ to\ increase$
17		the Repair and Maintenance line item to cover anticipated over expenditure.
18	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
19		authorizes FY 2008 Community Health, O'odham in Mexico (OIM) Budget
20		Modification and Amendment #1 total of \$8,500.00, which includes a capital
21		equipment cost-share contribution of \$5,500.00.
