9	WHEREAS,	the Pisinemo District Council on May 6, 2008, by Resolution No. 08-P-08, did appoint
10		Tony Murrietta to serve as alternate to representative Chester Antone; and
11	WHEREAS,	$\label{lem:councils} district councils are empowered to appoint alternates to the Legislative Council under the council co$
12		certain circumstances pursuant to Uniform Election Ordinance, Article IV, Section
13		5.B.; and
14	WHEREAS,	the Legislative Council, as a means of ensuring that each district is fully represented
15		on the Legislative Council, has recognized district council appointments to vacant
16		alternate seats in instances where vacancies have occurred outside of provisions
17		expressly outlined in the Election Ordinance for filling vacancies.
18	NOW, THER	EFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that (1) it hereby
19		recognizes the Pisinemo District Council appointment of Tony Murrietta to serve as
20		alternate to Legislative Council Representative Chester Antone and (2) seats alternate

22		is unable to attend a meeting in accordance with the Constitution and laws of the
