

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognizing the Pisinemo District Council Appointment for Tony Murrietta as Alternate
to Legislative Representative Chester Antone)**

LEGISLATIVE ORDER NO. 08-350

1 **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council to**
2 **“enact laws and ordinances for conducting and regulating elections” and provides**
3 **that the “decision of the Tohono O'odham Council in all election matters, including**
4 **the eligibility and qualifications of candidates, shall be final” (Constitution, Article VI,**
5 **Section 1(g) and Article X, Section 7); and**

6 **WHEREAS, Chester Antone was elected to the open Pisinemo Legislative Representative seat**
7 **during the May 26, 2007 general election at which time no Alternate designation was**
8 **made and which to date has remained vacant; and**

9 **WHEREAS, the Pisinemo District Council on May 6, 2008, by Resolution No. 08-P-08, did appoint**
10 **Tony Murrietta to serve as alternate to representative Chester Antone; and**

11 **WHEREAS, district councils are empowered to appoint alternates to the Legislative Council under**
12 **certain circumstances pursuant to Uniform Election Ordinance, Article IV, Section**
13 **5.B.; and**

14 **WHEREAS, the Legislative Council, as a means of ensuring that each district is fully represented**
15 **on the Legislative Council, has recognized district council appointments to vacant**
16 **alternate seats in instances where vacancies have occurred outside of provisions**
17 **expressly outlined in the Election Ordinance for filling vacancies.**

18 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that (1) it hereby**
19 **recognizes the Pisinemo District Council appointment of Tony Murrietta to serve as**
20 **alternate to Legislative Council Representative Chester Antone and (2) seats alternate**
21 **representative Tony Murrietta who shall serve when Representative Chester Antone**
22 **is unable to attend a meeting in accordance with the Constitution and laws of the**
23 **Tohono O'odham Nation and the rules and procedures of the Legislative Council.**

24 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12TH. Day of**
25 **JUNE, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST; -0-**
26 **NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section**
27 **1(g) and Article X, Section 7 of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**
