

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Economic Development Governmental Relations Representation Contract)**

**RESOLUTION NO. 08-352**

1 **WHEREAS, the Legislative Council is vested with the authority to “consult, negotiate and**  
2 **conclude agreements and contracts on behalf of the Tohono O’odham Nation with**  
3 **Federal, State and local governments and other Indian tribes or their departments,**  
4 **agencies, or political subdivisions, or with private persons or organizations on all**  
5 **matters within the authority of the Tohono O’odham Council” (Tohono O’odham**  
6 **Constitution, Article VI, Section 1(f)); and**

7 **WHEREAS, by Resolution No. 08-318, the Legislative Council approved an Economic**  
8 **Development Budget, which authorized the Chairman to administer the Economic**  
9 **Development Budget in consultation with the Economic Development Delegation;**  
10 **and**

11 **WHEREAS, the Chairman, in consultation with the Economic Development Delegation, has**  
12 **recommended that Triadvocates, LLC, be retained as a governmental relations**  
13 **consultant for the purposes of assisting the Economic Development Delegation in**  
14 **pursuing economic development projects within its purview; and**

15 **WHEREAS, the Chairman, in consultation with the Economic Development Delegation, has**  
16 **reviewed, and recommends that the Legislative Council approve, the attached**  
17 **Governmental Relations Representation Contract with Triadvocates, LLC**  
18 **(“Contract”) for the period commencing June 16, 2008 and ending September 30,**  
19 **2009; and**

20 **WHEREAS, the Budget and Finance and Domestic Affairs Committees have reviewed, and**  
21 **recommend that the Legislative Council approve, the Contract.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council hereby**  
23 **(1) approves the Governmental Relations Representation Contract with Triadvocates**  
24 **for the period commencing June 16, 2008 and ending September 30, 2009 in**  
25 **substantially the form attached hereto; provided that the Contract shall be funded**  
26 **from the Economic Development Budget approved by Resolution No. 08-318; and (2)**  
27 **authorizes the Chairman of the Nation to execute the Governmental Relations**  
28 **Representation Contract.**

29 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 12<sup>TH</sup> Day**  
30 **of JUNE, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
31 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
32 **Article VI of the Constitution of the Tohono O’Odham Nation, adopted by the Tohono O’Odham**  
33 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
34 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
