

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Certifying Election of Representative Verlon Jose as Legislative Council Chairperson)**

LEGISLATIVE ORDER NO. 08-356

1 WHEREAS, "The Tohono O'odham Council shall elect from among its own membership a
2 chairman and vice chairman." (Constitution of the Tohono O'odham Nation, Article
3 V, Section 4); and

4 WHEREAS, on June 12, 2008, by Legislative Order No. 08-354 the Legislative Council repealed the
5 certification of Representative Verlon Jose as the Legislative Council Chairman,
6 thereby leaving that office vacant; and


7 WHEREAS, on that same date, the Legislative Council followed the process provided in Article
8 XII, Section 2 of the Legislative Rules of the Tohono O'odham Legislative Council for
9 electing a new Council Chairperson; and

10 WHEREAS, Legislative Council Representative Verlon Jose received a majority of the votes cast
11 for the office of Legislative Council Chairperson.

12 NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby certifies
13 the election of Representative Verlon Jose as the Chairperson of the Tohono
14 O'odham Legislative Council.

15 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12TH. Day of
16 JUNE, 2008 at a meeting at which a quorum was present with a vote of 1,418.2 FOR; 921.9 AGAINST;
17 194.4 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article V,
18 Section 4 of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
19 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
20 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
