

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Appointment of Mr. Ryan G. Claw to the Position of Treasurer of  
the Tohono O'odham Nation)**

**RESOLUTION NO. 08-357**

1 **WHEREAS, Article VII, Section 2 (e) of the Tohono O'odham Nation Constitution vests the**  
2 **Chairman with authority to appoint the Treasurer of the Tohono O'odham Nation**  
3 **(Nation) with the approval of the Tohono O'odham Legislative Council; and**  
4 **WHEREAS, the Chairman of the Tohono O'odham Nation, in consultation with the Tohono**  
5 **O'odham Legislative Council Budget & Finance Committee, has identified Mr. Ryan**  
6 **G. Claw as the appointee for the Nation's Treasurer position; and**  
7 **WHEREAS, Mr. Ryan G. Claw is qualified to assume the position of Treasurer and whose**  
8 **background investigation has been completed; and**  
9 **WHEREAS, Mr. Ryan G. Claw has accepted the position and appointment upon approval of the**  
10 **Tohono O'odham Legislative Council.**  
11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
12 **approve the appointment of Mr. Ryan G. Claw as the Treasurer of the Tohono**  
13 **O'odham Nation who shall serve at the pleasure of the Chairman of the Tohono**  
14 **O'odham Nation in accordance with Article VII, section 2(e) of the Tohono O'odham**  
15 **Nation Constitution.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>. Day**  
17 **of JUNE, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
18 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 2 (e) of**  
19 **Article VII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
20 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
21 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


