5		not been performed for several years; and
6	WHEREAS,	the Office of the Chairman and Office of the Treasurer in consultation with the
7		Legislative Budget & Finance Committee have determined that a \$100.00 net
8		payment for each of the remaining seven (7) pay periods to each Employee for all
9		Employees and Officials of the Executive Branch, Legislative Branch and Judicial
10		Branch for Fiscal Year 2008 is necessary for the Nations employees based on the
11		current harsh economic situation; and
12	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves a
13		\$100.00 net payment to each Employee for each of the remaining seven (7) pay
14		periods for all Employees and Officials of the Executive Branch, Legislative Branch
15		and Judicial Branch for Fiscal Year 2008.
16	BE IT FURTH	IER RESOLVED that the total budgetary requirement for the \$100.00 net payment to
17		each employee for each of the remaining seven (7) pay periods will be a total amount
18		of \$1,438,879.68 and shall be funded by the general fund for fiscal year 2008.

20		of the remaining seven (7) pay periods shall begin with the pay period beginning
21		June 22, 2008 and shall remain in effect for the remaining seven pay periods of Fiscal
