

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Hikiwan District FY2008 Mining Royalties / Additional
Apportionment of Gaming Revenues)

RESOLUTION NO. 08-371

1 **WHEREAS, the Tohono O'Odham Legislative Council by Resolution 07-461 approved the initial**
2 **apportionment of gaming revenues based on projected Allocation of \$18,746,856.57**
3 **to all districts; and**

4 **WHEREAS, the Tohono O'Odham Legislative Council by Resolution 07-764 approved the**
5 **amounts per district in which Hikiwan District was apportioned the amount of**
6 **\$16,016.49; and**

7 **WHEREAS, the Tohono O'Odham Legislative Council by Resolution 07-752 approved the**
8 **apportionment of Mining Royalties of \$2,932,566.45 to all districts by equal**
9 **distribution; and**

10 **WHEREAS, the portion of Mining Royalties to the Hikiwan District is \$266,596.94; and**

11 **WHEREAS, the Hikiwan District Council by Resolution HDC-08-024 is presenting its FY2008**
12 **Hikiwan District Budget Amendment of \$282,613.43 comprised of the FY08 Gaming**
13 **revenues of \$16,016.49 and Mining Royalties equal distribution of \$266,596.94; and**

14 **WHEREAS, the FY2008 Budget Amendment No. 02 is budgeting \$128,000 as an amendment to its**
15 **FY2008 Budget; and**

16 **WHEREAS, the balance of \$154,613.43 is recommended to be deposited into the Hikiwan**
17 **District's Bank of America Money Market Account.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby**
19 **approves the FY2008 Hikiwan District Budget Amendment No. 02 of \$282,613.43**
20 **comprised of the FY08 Gaming revenues of \$16,016.49 and Mining Royalties equal**
21 **distribution of \$266,596.94.**

22 **BE IT FURTHER RESOLVED that \$128,000 of the Hikiwan District Budget Amendment No. 2 of**
23 **\$282,613.43 amends the Hikiwan District FY 2008 budget to a new total of**
24 **\$2,100,763.06.**

25 **BE IT FURTHER RESOLVED that the balance of \$154,613.43 is approved for Deposit into the**
26 **Hikiwan District's Bank of America Money Market Account.**

27 **BE IT FINALLY RESOLVED that the Tohono O'Odham Legislative Council hereby Authorizes the**
28 **Chairman and any designated official to expend and administer the budget as**
29 **attached, provided that any amendments affecting the funds or funding level shall**
30 **be submitted for further prior approval by the Tohono O'Odham Legislative Council.**

31 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH. Day**
32 **of JUNE, 2008 at a meeting at which a quorum was present with a vote of 1,670.35 FOR; -0- AGAINST;**
33 **667.65 NOT VOTING; and 196.5[03] ABSENT, pursuant to the powers vested in the Council by Section**
34 **1 (d)(2)&(3) of Article VII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
35 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
36 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
37 **Stat. 984).**
