

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Artesia/Little Tucson Community 2008 Budget Modification/Amendment #1)**

RESOLUTION NO. 08-378

1 **WHEREAS, at a regular scheduled meeting of the Baboquivari District Council, held on May 20,**  
2 **2008 at which a quorum was present, the Artesia/Little Tucson Community**  
3 **Representative presented their 2008 budget modification/amendment #1; and**

4 **WHEREAS, the Baboquivari District Council approved the Artesia/Little Tucson Community**  
5 **approved the 2008 Budget modification/amendment #1; and**

6 **WHEREAS, on May 09, 2008 Artesia/Little Tucson Community Members approved the Budget**  
7 **Modification/Amendment #1 by a vote of 13 For, 0 Against, 0 Not Voting; and**

8 **WHEREAS, the budget modification/amendment #1 will decrease line item 772.32 R/M Building**  
9 **by \$6,593.00, and apply as follows:**

17 **District 2008 Artesia/Little Tucson Community budget of \$221,890.51; and**

18 **WHEREAS, this budget modification/amendment #1 will not affect the current Baboquivari**  
19 **District 2008 budget of \$1,838,055.76.**

20 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves**  
21 **Artesia/Little Tucson Community 2008 budget modification/amendment #1, to move**  
22 **monies from line item 772.32 R/M/ Building of \$6,593.00 and apply to line items to**  
23 **the above mentioned line items, and does not affect their current budget of**  
24 **\$221,890.51, and does not affect the overall Baboquivari District 2008 budget of**  
25 **\$1,838,055.76.**

26 **BE IT FINALLY RESOLVED that any changes in the justification, additions and/or the transfer of**  
27 **funds between budget line items are to be reviewed by the Budget and Finance**  
28 **Committee and approved by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26<sup>TH</sup>. Day**  
30 **of JUNE, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
31 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1**  
32 **(d)(2)(3) & (f) of Article VII of the Constitution of the Tohono O'Odham Nation, adopted by the**  
33 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
35 **18, 1934 (48 Stat. 984).**
