

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Arizona a Change in Scope for the 12% Distribution Grant Agreement for the  
Arizona Board of Regents, University of Arizona on behalf of College of  
Education, Department of Language, Reading and Culture)**

**RESOLUTION NO. 08-391**

- 1 **WHEREAS, by Resolution No. 05-647, the Tohono O'odham Nation's (the "Nation") approved a**  
2 **new tribal-state gaming compact (the "compact") with the State of Arizona; and**  
3 **WHEREAS, pursuant to Section 12(d) of the Compact the Nation agreed to contribute twelve**  
4 **percent of the tribal contribution (the "12% Distribution") to cities, towns, and**  
5 **counties, for government services that benefit the general public; and**  
6 **WHEREAS, through Resolution 07-689, the Legislative Council approved final agreements for**  
7 **the Nation's fiscal year 2007 12% Distribution, including one grant to the University**  
8 **of Arizona College of Education, through the City of Tucson, in the amount of**  
9 **\$15,000.00; and**  
10 **WHEREAS, the original purposes for the grant was to purchase an indigenous and international**  
11 **book collection; and**  
12 **WHEREAS, the University of Arizona College of Education has requested that \$3,500 of the award**  
13 **grant be modified for the purpose of hiring a Native American graduate student to**  
14 **identify the indigenous and international book collection to be purchased.**  
15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
16 **a change in the scope of the grant awarded to the University of Arizona College of**  
17 **Education to allow for payment of:**  
18 **- \$3,500.00 to hire a Native American graduate student.**  
19 **- \$11,500.00 for the purchase of an indigenous and international book collection.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> Day**  
21 **of JUNE, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
22 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
23 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
