amount of \$266,596.95, Apportionment of Mining Royalties)**

RESOLUTION NO. 08-400

1 **WHEREAS, on December 4, 2007, the Tohono O'Odham Legislative Council passed Resolution No.**
2 **07-751, "Approving FY 2008 Apportionment of Mining Royalties by Equal Distribution";**

3 **and**

4 **WHEREAS, the Sif-Oidak District Council passed Resolution No. SODC-08-013, "Approving the FY**
5 **2008 Home Repair/Renovation Budget"; and**

6 **WHEREAS, the Tohono O'Odham Legislative Budget and Finance Committee has reviewed the**
7 **proposed budget on June 17, 2008 and is in agreement; and**

8 **WHEREAS, due to the fact that there are a great number of substandard homes on the Tohono**
9 **O'odham Nation, it is only appropriate that the Sif-Oidak District begin to consider**
10 **some of the homes that are in dire need of repairs and renovations.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does**
12 **hereby approve the Sif-Oidak District FY 2008 Home Repair/Renovation Budget in the**
13 **amount of \$266,596.95, apportionment of Mining Royalties.**

14 **BE FURTHER RESOLVED that this entire amount of \$266,596.95, be transferred to the Sif-Oidak**
15 **District's Operating Account at Wachovia Securities to be expended.**

16 **BE IT FINALLY RESOLVED that any amendment affecting the funding or funding levels of the**
17 **attached Budget shall be submitted for further prior approval by the Tohono**
18 **O'Odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
20 **of JUNE, 2008 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and 199.5 [05] ABSENT, pursuant to the powers vested in the Council by Section**
22 **1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**
