

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu-Vo Community Budget Amendment # 1 Fiscal Year 2008
of the Gu-Vo District)

RESOLUTION NO. 08-402

1 **WHEREAS, the Gu-Vo District did bring forth the Gu-Vo Community Budget Amendment No. 1 for**
2 **the Fiscal Year 2008 budget; and**

3 **WHEREAS, the Gu-Vo District Governing Council did review the needs of the Gu-Vo Community**
4 **to modify it's budget and add funds in the areas that have been depleted; and**

5 **WHEREAS, the proposed budget amendment from the Gu-Vo Community has gone through**
6 **proper review from the Gu-Vo District and the Tohono O'odham Legislative Branch**
7 **and Finance Committee; and**

8 **WHEREAS, it is the recommendation of the Budget & Finance Committee to approve Budget**
9 **Amendment #1 for the Gu-Vo District Community; and**

10 **WHEREAS, language to justification for line item 852 changes by adding the following: "\$4,000.00**
11 **budget for community Youth and Youth Monitor workers bonus's @\$500.00 per Youth**
12 **and Youth Monitor and to be given after successfully completing 6 weeks of summer**
13 **work."**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **the Budget Amendment #1 for the Gu-Vo Community Budget Amendment adjusting**
16 **the language to line item 852 by adding the following; "\$4,000.00 budget for**
17 **community Youth and Youth Monitor workers bonus's @\$500.00 per Youth and Youth**
18 **Monitor and to be given after successfully completing 6 weeks of summer work."**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairman or Vice Chairman and any designated official to expand and administer the**
21 **budget as attached, provided that any amendments affecting the funds or funding**
22 **level shall be submitted for further prior approval by the Tohono O'odham Legislative**
23 **Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH. Day**
25 **of JUNE, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and [03]ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
27 **&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
