- 1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2007 Venito Garcia Library**
2 **& Archives Bookmobile Project (IMLS-NALS No. NG-03-06-0270-06) Budget; and**
3 **WHEREAS, a total in-kind match for the grant in the amount of \$51,050.28 will be provided from**
4 **the Education Administration 01-1201 budget over the span of the two year grant;**
5 **and**
6 **WHEREAS, the salary and fringe benefits from this budget for the Library Clerk will be**
7 **retroactive to October 1, 2007; and**
8 **WHEREAS, the Venito Garcia Library & Archives has submitted for review and approval the**
9 **proposed FY 2008 Budget to carry forward the remaining \$86,654.15 from the**
10 **approved FY 2007 funds for a total budget of \$120,014.15; and**
11 **WHEREAS, the Venito Garcia Library & Archives Carryover Budget has been reviewed by the**
12 **Human Resources Development Committee and the Budget and Finance Committee.**
13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
14 **approve and authorizes FY 2007 carryover funds of \$86,654.15 for a total FY 2008**
15 **budget of \$120,014.15 for the Bookmobile Project.**
16 **BE IT FURTHER RESOLVED that a total in-kind match for the grant in the amount of \$51,050.28 will**
17 **be provided from the Education Administration 01-1201 budget over the span of the**
18 **two year grant.**
19 **BE IT FURTHER RESOLVED that the salary and fringe benefits from this budget for the Library**
20 **Clerk will be retroactive to October 1, 2007.**
21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
22 **Chairperson and any designated official to expend and administer the budget as**
23 **attached, provided that any amendments affecting the funds or funding level shall**
24 **be submitted for further prior approval by the Tohono O'odham Legislative Council**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH. Day**
26 **of JUNE, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
28 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
29 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
30 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
