

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY2008 General Support Services - Accounting Office Budget Amendment No. 3)**

**RESOLUTION NO. 08-420**

1 **WHEREAS, the Tohono O'odham Legislative Council did approve the FY2008 Accounting Office**  
2 **Budget pursuant to Legislative Council Resolution No. 07-588; and**

3 **WHEREAS, the Accounting Office of the Executive Branch submits for review and approval FY2008**  
4 **Accounting Office Budget Amendment No. 3 transferring funds within line items to**  
5 **decreasing line item 610, revise salary justification for reclassification of the**  
6 **Controller position from an annual salary of \$64,667.81 to \$85,000.00 and increase line**  
7 **items 720, 750 and 770; and**

8 **WHEREAS, the FY2008 Accounting Office Budget Amendment No. 3 has been reviewed and**  
9 **approved by the Budget and Finance Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
11 **the FY2008 Accounting Office Budget Amendment No. 3 which transfers funds within**  
12 **line items, decreasing line items, 610, revise salary justification for reclassification of**  
13 **the Controller position from an annual salary of \$64,667.81 to \$85,000.00 and**  
14 **increases line items 720, 750 and 770.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
16 **Nation's Officials, to wit: the Chairman, Vice-Chairman and any designated official are**  
17 **authorized to administer the budget, provided however, that any amendments**  
18 **affecting the funds or funding levels of the budget shall be submitted for further prior**  
19 **approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day**  
21 **of JULY, 2008 at a meeting at which a quorum was present with a vote of 2,221.0 FOR; -0- AGAINST;**  
22 **313.5 NOT VOTING; and [02]ABSENT, pursuant to the powers vested in the Council by Section 1 (d)**  
23 **and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**


