12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
13	approve the appointment of Ms Theoria Campillo as the Executive Director of the
14	Tohono O'odham Gaming Office.
15	BE IT FINALLY RESOLVED that Ms Theoria Campillo shall serve at the pleasure of the Chairman
16	of the Tohono O'odham Nation.
