

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Appointment of Ms Theoria Campillo as the Executive Director  
to the Tohono O'odham Gaming Office)**

**RESOLUTION NO. 08-421**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation provides the Chairman of the Tohono**  
2 **O'odham Nation the authority to appoint heads of governmental departments with the**  
3 **approval of the Tohono O'odham Legislative Council (Article VII Section 2e); and**

4 **WHEREAS, the Chairman of the Tohono O'odham Nation, in consultation with the Tohono**  
5 **O'odham Legislative Commerce Committee, has identified Ms Theoria Campillo as the**  
6 **appointee for the Nation's Executive Director to the Tohono O'odham Gaming Office;**  
7 **and**

8 **WHEREAS, Ms Theoria Campillo is qualified to assume the position of Executive Director of**  
9 **Tohono O'odham Gaming Office; and**

10 **WHEREAS, Ms Theoria Campillo has accepted the position and appointment upon approval of the**  
11 **Tohono O'odham Legislative Council.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
13 **approve the appointment of Ms Theoria Campillo as the Executive Director of the**  
14 **Tohono O'odham Gaming Office.**

15 **BE IT FINALLY RESOLVED that Ms Theoria Campillo shall serve at the pleasure of the Chairman**  
16 **of the Tohono O'odham Nation.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day**  
18 **of JULY, 2008 at a meeting at which a quorum was present with a vote of 1,993.7 FOR; 540.8**  
19 **AGAINST; -0- NOT VOTING; and [02]ABSENT, pursuant to the powers vested in the Council by Section**  
20 **1 (b) and 2 (e) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
23 **18, 1934 (48 Stat. 984).**
