

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Mr. Patrick H. Andrews as the Executive Director to
Tohono O'odham Nation Department of Education)**

RESOLUTION NO. 08-422

1 **WHEREAS, the Constitution of the Tohono O'odham Nation provides the Chairman of the Tohono**
2 **O'odham Nation the authority to appoint heads of governmental departments with the**
3 **approval of the Tohono O'odham Legislative Council (Article VII Section 2e); and**

4 **WHEREAS, the Chairman of the Tohono O'odham Nation, in consultation with the Tohono**
5 **O'odham Legislative Human Resources Development Committee, has identified Mr.**
6 **Patrick H. Andrews as the appointee for the Nation's the Executive Director to Tohono**
7 **O'odham Nation Department of Education; and**

8 **WHEREAS, Mr. Patrick H. Andrews is qualified to assume the position of Executive Director for the**
9 **Tohono O'odham Nation Department of Education; and**

10 **WHEREAS, Mr. Patrick H. Andrews has accepted the position and appointment upon approval of**
11 **the Tohono O'odham Legislative Council.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve the appointment of Mr. Patrick H. Andrews as the Executive Director for the**
14 **Tohono O'odham Nation Department of Education.**

15 **BE IT FINALLY RESOLVED that Mr. Patrick H. Andrews shall serve at the pleasure of the Chairman**
16 **of the Tohono O'odham Nation.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
18 **of JULY, 2008 at a meeting at which a quorum was present with a vote of 1,755.85 FOR; 606.65**
19 **AGAINST; 172.0 NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by**
20 **Section 1 (b) and 2 (e) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
21 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat. 984).**
