

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2008 Budget Amendment No. 1 for the Tohono O'odham Nation Police**  
**Department BIA 638 Ranger Budget in the amount of \$93,952.57 changing budget**  
**amount from \$1,019,830.32 to \$1,113,782.89)**

**RESOLUTION NO. 08-423**

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**  
2 **Corrections Programs under the 638 BIA Master Contract; and**

3 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has received from the BIA a**  
4 **modification no. 65 in the amount of \$710,672.00; and**

5 **WHEREAS, the TONPD has used part of the received funds in the amount of \$78,720.21 to increase**  
6 **line items 610 Salaries, 610.5 Other Compensation, 620 Fringe Benefits, for five current**  
7 **Ranger positions that are funded at a Ranger salary; and**

8 **WHEREAS, with the possibility of five Ranger positions moving up to the Ranger II salary these**  
9 **line items were increased to meet the increase in salary; and**

10 **WHEREAS, with those Ranger positions that move up to a Ranger II position will require a change**  
11 **in uniform which increases the uniform line item by \$5,000.01; and**

12 **WHEREAS, with this increase of \$78,720.21 will also increase the Indirect Cost charges by**  
13 **\$15,232.36.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
15 **approves and authorizes Budget Amendment No. 1 to increase line items 610 Salary,**  
16 **610.5 Other Compensation, 620 Fringe Benefits, 723 Uniforms in the amount of**  
17 **\$93,952.57 changing the current budget amount of \$1,019,830.32 to \$1,113,782.89 and**  
18 **increasing the IDC in the amount of \$15,232.36.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
20 **Chairman, Vice-Chairman and any designated officials are authorized to administer**  
21 **the attached budget, provided, however that any amendments affecting these funding**  
22 **levels that are budgeted shall be submitted for prior approval by the Tohono O'odham**  
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
25 **of JULY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
26 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
27 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
28 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
29 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
