

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Intergovernmental Agreement with Arizona Department of Public Safety)**

RESOLUTION NO. 08-424

1 **WHEREAS, the Tohono O'odham Nation (Nation) employs certified police officers to conduct**
2 **criminal investigations; and**

3 **WHEREAS, the conducting such investigations often requires forensic science examinations; and**

4 **WHEREAS, the Tohono O'odham Nation Police Department(TONPD) does not currently employ**
5 **a forensic laboratory criminalist, and for that reason the Nation's forensic science**
6 **examination must be conducted by another agency; and**

7 **WHEREAS, the Arizona Department of Public Safety operates such a laboratory and employs a**
8 **forensic criminalist; and**

9 **WHEREAS, the Nation and the Arizona Department of Public Safety have negotiated an**
10 **Intergovernmental Agreement providing that the Nation can pay for services from the**
11 **Arizona Department of Public Safety Crime Laboratory; and**

12 **WHEREAS, the Domestic Affairs Committee has reviewed the Intergovernmental Agreement and**
13 **recommends approval.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves**
15 **the Intergovernmental Agreement between the Tohono O'odham Nation and the**
16 **Arizona Department of Public safety substantially in the form attached hereto, and**
17 **authorizes the Chairman of the Nation to execute the Intergovernmental Agreement.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
19 **Chairman and any designated official to expend and administer the budget as**
20 **attached, provided that any amendments affecting the funds or funding level shall be**
21 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
23 **of JULY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [02]ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
25 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
26 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
27 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
