

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2008 budget amendment no. 3 to use salary savings in the amount  
of \$127,835.42 for twenty additional beds at the Gallup McKinley Adult Detention  
Center/Jail changing the budget amount from \$4,846,793.20 to \$4,824,130.48)**

**RESOLUTION NO. 08-425**

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**  
2 **Corrections Programs under the 638 BIA Master Contract; and**

3 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) Corrections Program has**  
4 **salary savings deriving from vacant positions from February 1, 2008 thru May 31, 2008**  
5 **in the amount of \$127,835.42 leaving 4 months salary for new personnel; and**

6 **WHEREAS, the TONPD Corrections Program has identified the need to utilize these salary savings**  
7 **for twenty additional beds at the Gallup McKinley Adult Detention Center/Jail in the**  
8 **amount of \$117,120.00 to be added to line item 810 Professional Service; and**

9 **WHEREAS, the twenty additional beds will be from June 1, 2008 thru September 30, 2008; and**

10 **WHEREAS, the TONPD Corrections Program has also increase the line item 712 Gas, Oil &**  
11 **Coolants in the amount of \$10,715.42; and**

12 **WHEREAS, this budget amendment will change to Indirect Cost from \$434,785.79 to \$412,123.07**  
13 **a difference of \$22,662.72.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
15 **approves and authorizes Budget Amendment No. 3 to use salary savings to increase**  
16 **line item 810 Professional Service for additional beds at the Gallup McKinley Adult**  
17 **Detention Center/Jail in the amount of \$117,120.00 and to increase line item 712 Gas,**  
18 **Oil & Coolants in the amount of \$10,715.42. This budget amendment will also decrease**  
19 **the indirect cost from \$434,785.79 to \$412,123.07 a difference of \$22,662.72.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
21 **Chairman, Vice-Chairman and any designated officials are authorized to administer**  
22 **the attached budget, provided, however that any amendments affecting these funds**  
23 **or funding levels that are budgeted shall be submitted for prior approval by the**  
24 **Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day**  
26 **of JULY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
27 **-0- NOT VOTING; and [02]ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
28 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
29 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
30 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
