9	distribution to the districts on an equal basis totaling \$266,596.95 per district.

11	hereby with the authority granted under the Tohono O'odham Constitution Article IX,						
12	Section 7, approves the budget amendment of the San Xavier District FY08 budget in						
13	the amount of \$266,596.96.

15	the Treasurer to wire transfer these funds to the San Xavier District at the earliest
