RESOLUTION NO. 08-434

1 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has successfully received an**
2 **award with the Office of Justice Program(OJP) Office on Violence Against Women (OVW)**
3 **grant for arrest policies and enforcement of protection orders program funded**
4 **through the US Department of Justice (DOJ) for the projected amount of \$353,063.00**
5 **under grant number 2006-WE-AX-0006; and**

6 **WHEREAS, the grant amount is funding for a two year period beginning October 1, 2006 thru**
7 **September 30, 2008; and**

8 **WHEREAS, the TONPD has received an approved no cost grant extension from July 1, 2008 thru**
9 **June 30, 2009; and**

10 **WHEREAS, with this no cost grant extension the salary line item has been adjusted to cover the**
11 **remaining months of July 1st thru September 30, 2008 for the three positions under this**
12 **grant; and**

13 **WHEREAS, the salaries and fringe has been adjusted for October 1, 2008 thru June 30, 2009; and**

14 **WHEREAS, the items being budgeted for are estimated and will be adjusted at a later date if**
15 **needed.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council that it hereby**
17 **accepts, approves and authorizes the no cost grant extension for the Office of Justice**
18 **Program Office on Violence against Women Grant No. 2006-WE-AX-0006 from July 1,**
19 **2008 thru June 30, 2009.**

20 **BE IT FURTHER RESOLVED that the salary line items 610 Salary & 620 have been adjusted to cover**
21 **the remaining months from July 1st thru September 30, 2008 and to include the salary**
22 **adjustment for FY 2009.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
24 **the Chairman and any designated official to expend and administer the budget as**
25 **attached, provided that any amendments affecting the funds or funding level shall be**
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
28 **of JULY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
29 **-0- NOT VOTING; and [03]ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
30 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
31 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
32 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
