

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Youth Suicide Prevention FY2008 Budget Amendment #1 that creates
the Position Administrative Assistant cost shared with Recovery Community Services)

RESOLUTION NO. 08-436

1 **WHEREAS, the Tohono O'odham Legislative Council initially approved Youth Suicide Prevention**
2 **Budget in FY 2008 in Resolution No. 07-601; and**

3 **WHEREAS, the Tohono O'odham Legislative Council approved FY2008 Youth Suicide Prevention**
4 **Budget; and**

5 **WHEREAS, there is sufficient saving of \$130,895.01 as of 6/30/08 expenditure report to cover**
6 **increases in line items and to fund position in the amount of \$58,254.79; and**

7 **WHEREAS, the Youth Suicide Program requires Administrative Assistant support of the planned**
8 **suicide prevention activities; and**

9 **WHEREAS, this budget is amendment to establish an Administrative Assistant position along with**
10 **salary and fringe benefits which amends the FY 2008 Budget; and**

11 **WHEREAS, the Administrative Assistant position will be cost shared between the Youth Suicide**
12 **Prevention and Recovery Community Services Budget; and**

13 **WHEREAS, the Youth Suicide Prevention Grant cost share amount is \$8,950.72 and the Recovery**
14 **Community Services amount is \$ 18,172.67 for a total of \$27,123.39 with fringe benefits;**
15 **and**

16 **WHEREAS, increases are applied in line items: 650, 660, 662, 710, 711, 720, 721, 810, 860 and**
17 **decreases in line items: 610, 620, and 900.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
19 **approves the FY2008 Youth Suicide Prevention Amendment #1 of \$58,254.79 which**
20 **creates the Administrative Assistant position with the salary of \$8,950.22, fringe**
21 **benefits included, and increase in line item: 650, 660, 662, 710, 711, 720, 721, 722, 810,**
22 **860 and decreases in line items: 610, 620, and 900 as per attached budget.**

23 **BE IT FURTHER RESOLVED the Youth Suicide Prevention Grant cost share amount is \$8,950.72**
24 **and the Recovery Community Services amount is \$18,172.67 for a total of \$27,123.39**
25 **with fringe benefits.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby Authorizes the**
27 **Chairman, the Vice-Chairman and any designated official to expend and administer**
28 **the budget as attached, provided that any amendments affecting the funds or funding**
29 **level shall be submitted for further prior approval by the Tohono O'odham Legislative**
30 **Council.**
