

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2008 Adult Care Services Program Budget Amendment #1)

RESOLUTION NO. 08-437

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Bureau of Indian Affairs; and**

3 **WHEREAS, the Adult Care Services fiscal year 2008 budget amendment 1 has been prepared to**
4 **decrease the funds that were budgeted for Tuition and Registration; Utilities;**
5 **Equipment Repair and Maintenance; Vehicle Repair and Maintenance; and Public**
6 **Relations line items; and**

7 **WHEREAS, the funds from the decreased line items will be utilized in the Mileage-GSA and**
8 **Communication Expense line items; and**

9 **WHEREAS, the amount for the Indirect Cost increased because funds of \$1,000.00 was taken from**
10 **the Public Relations line item that Indirect Cost *does not* apply and transferred into**
11 **another line item where Indirect Cost *does* apply.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
13 **approves:**

- 14 **1. The Adult Care Services fiscal year 2008 budget amendment 1 to *decrease* the**
15 **funds that were budgeted for Tuition and Registration; Utilities; Equipment**
16 **Repair and Maintenance; Vehicle Repair and Maintenance; and Public Relations**
17 **line items.**
- 18 **2. That the funds from the decreased line items be utilized in the Mileage-GSA and**
19 **Communication Expense line items.**
- 20 **3. The Indirect Cost increase due to the funds of \$1,000.00 being taken from the**
21 **Public Relations line item that Indirect Cost *does not* apply and transferred into**
22 **another line item where Indirect Cost *does* apply.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation officials, to wit: The Chairman is hereby**
24 **authorized to negotiate and execute the grant, provided however, that any**
25 **amendments affecting the funding or funding levels of this contract shall be**
26 **submitted for further prior approval by this Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day**
28 **of JULY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
29 **-0- NOT VOTING; and [04]ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
30 **& (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**
