4	decrease the funds that were budgeted for Tuition and Registration; Utilities
5	Equipment Repair and Maintenance; Vehicle Repair and Maintenance; and Public
6	Relations line items; and
7	WHEREAS, the funds from the decreased line items will be utilized in the Mileage-GSA and
8	Communication Expense line items; and
9	WHEREAS, the amount for the Indirect Cost increased because funds of \$1,000.00 was taken fron
10	the Public Relations line item that Indirect Cost <i>does not</i> apply and transferred into
11	another line item where Indirect Cost <i>does</i> apply.
12	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
13	approves:
14	1. The Adult Care Services fiscal year 2008 budget amendment 1 to <i>decrease</i> the
15	funds that were budgeted for Tuition and Registration; Utilities; Equipmen
16	Repair and Maintenance; Vehicle Repair and Maintenance; and Public Relations
17	line items.
18	2. That the funds from the decreased line items be utilized in the Mileage-GSA and
19	Communication Expense line items.
20	3. The Indirect Cost increase due to the funds of \$1,000.00 being taken from the
21	Public Relations line item that Indirect Cost <i>does not</i> apply and transferred into
22	another line item where Indirect Cost <i>does</i> apply.
23	BE IT FINALLY RESOLVED that the Tohono O'odham Nation officials, to wit: The Chairman is hereby
24	authorized to negotiate and execute the grant, provided however, that any
25	amendments affecting the funding or funding levels of this contract shall be
26	submitted for further prior approval by this Council.
