

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family Assistance – FY08 Food Distribution Program, Nutrition Education Budget Amendment #1 - Account No. 11-1316)

RESOLUTION NO. 08-438

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2008 grant with the United**
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, by Resolution Number 07-953, the Tohono O'odham Legislative Council approved the**
5 **FY2008 Nutrition Education budget in the amount of \$1,939.00; and**

6 **WHEREAS, the Nation was notified of the final Grant Award from the USDA; and**

7 **WHEREAS, the Food Distribution Program, Nutrition Education funds available to the Tohono**
8 **O'odham Nation for FY2008 through the USDA has decreased by \$148.75 from \$1,939.00**
9 **to \$1,790.25; and**

10 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**
11 **Division, Food Distribution Program has prepared the FY2008 Nutrition Education**
12 **Budget Amendment #1 which incorporates increases/decreases in line items: Supplies**
13 **Other and Kitchen Supplies, and Indirect Cost. The budget amendment amount also**
14 **reflects the decrease from \$1,939.00 to \$1,500.00 and the indirect cost in the amount**
15 **of \$290.25 for a total of \$1,790.25; and**

16 **WHEREAS, the Executive Branch developed and obtained committee approval of the FY2008 Food**
17 **Distribution, Nutrition Education budget amendment #1 in the amount of \$1,790.25.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
19 **approve Amendment #1 which reflects the final grant award in the amount of**
20 **\$1,790.25 and authorizes the Executive Branch to expend funds in the attached FY2008**
21 **Food Distribution Program, Nutrition Education Budget Amendment #1, effective**
22 **October 01, 2007 through September 30, 2008. The budget amendment reflects the**
23 **decrease from \$1,939.00 to \$1,790.25 and the indirect cost decrease of \$24.12 from**
24 **\$314.37 to \$290.25.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman, Vice-**
26 **Chairman and any designated officials are hereby authorized to negotiate, expend**
27 **and execute Budget Amendment #1 as attached, provided however, that that any**
28 **amendments affecting the funds or funding levels shall be submitted for further prior**
29 **approval by the Tohono O'odham Legislative Council.**
