

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2008 Tohono O'odham Department of Health and Human Services,
Division of Community Health Service Budget Modification and Amendment No. 1)

RESOLUTION NO. 08-440

1 **WHEREAS, the Division of Community Health Service (DCHS) is the umbrella Division and**
2 **oversees: Community Health Representatives, Home Health, Community Counseling**
3 **& Relations, Women, Infants and Children, Maternal and Child Health, Tuberculosis**
4 **Control and Prevention, Dialysis Patient Advisory Committee, O'odham in Mexico,**
5 **Motor Vehicle Injury Prevention, Family Violence Prevention, Violence Against**
6 **Women, Public Health Preparedness-BT, Cancer Awareness and Comprehensive**
7 **Cancer Control; and**

8 **WHEREAS, the Division of Community Health is part of the historically contracted Indian Health**
9 **Service functions and its program budget is incorporated into the Department of**
10 **Health and Human Service budget; and**

11 **WHEREAS, the FY 2008 Department of Health and Human Service budget was approved through**
12 **Resolution No. 07-612; and**

13 **WHEREAS, there are anticipated over expenditures in travel, special activities, and vehicle**
14 **maintenance; and**

15 **WHEREAS, the redistribution of funds includes a \$13,405.95 decrease in account 810 Professional**
16 **Services, which is a pass-through (no indirect charge) account; and**

17 **WHEREAS, the net result of the fund redistribution is an increase of \$2,594.05 in the indirect cost**
18 **charges which brings the new total indirect amount from \$338,286.80 to \$340,880.85;**
19 **and**

20 **WHEREAS, there is no change in the new operational budget total amount, which is the base**
21 **program amount.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 23 **1. Approves the Division of Community Health Service budget modification for**
24 **realignment of program base operational funds.**
- 25 **2. Approves the \$2,594.05 increase in the indirect cost amount.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation's officials, to wit: the Chairman and Vice Chairman and any designated official**
28 **are authorized to administer and expend these funds, provided however, that any**
29 **amendments affecting the funds or funding levels of the contract shall be submitted**
30 **for further prior approval by the Tohono O'odham Legislative Council.**
