

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2008 Tohono O'odham Department of Health and Human Services, Division of Community Health, Motor Vehicle Injury Prevention STOP Project Budget Modification and Amendment No.1)

RESOLUTION NO. 08-444

1 **WHEREAS, the Tohono O'odham Department of Health and Human Services has successfully**
2 **operated the Motor Vehicle Injury Prevention Grant known as the STOP Project; and**

3 **WHEREAS, the Year Four, FY 2008 STOP Project budget was approved through Resolution No. 08-**
4 **040; and**

5 **WHEREAS, there are anticipated over expenditures in program operations through the end of the**
6 **fiscal year; and**

7 **WHEREAS, the net effect of these budget adjustments results in a decrease in direct operations**
8 **and off setting an increase of \$810.64 in Indirect Cost Charges; and**

9 **WHEREAS, there is no separate cost pool for Indirect, and all funding must be accounted under**
10 **the original total grant amount.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 12 **1. Approves the STOP Project budget modification for operational adjustments.**
- 13 **2. Approves the Indirect Cost increase of \$810.64.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
15 **Nation officials, to wit: the Chairman and Vice Chairman and any designated official**
16 **are hereby authorized to negotiate and execute the grant, provided however, that any**
17 **amendments affecting the funds or funding levels of the grant shall be submitted for**
18 **further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
20 **of JULY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
22 **& (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
